Format:

- 16 teams of four players and one coach.
 - 4 out of Province Teams and 12 Ontario Teams- maximum two teams per club –different boxes
 - 1 girl minimum, players ranked #1 through #4, coaching on change over only
 - Players play six singles and six doubles
- 4 boxes of four teams play round robin, 3 rounds per team [Boxes set up by OTA]
- All team matches three rotations
 - First rotation, two doubles matches - pro set, no ads, 5 point tie breaker at 7 all, 1 point per match won, second rotation, #3 and # 4 singles, third rotation, #2 and #1 singles
 - Singles best 2 out of 3 short sets, no ads, with 5 point tie breaker at 3 all, 3rd set is 7 point tie break. Teams get one point for each set won
- Teams are ranked 1 through 4 in box [maximum 30 points- 6 doubles, 24 singles]
 - In case of tie: head to head points , still tied: number of games, tie breaker won, still tied, team with less games lost and tie breaker loss, still tied, draw by Tournament Director
- #1 ranked teams in each box makes it to Championship flight #1, same for #2, #3, #4
